## **Instructions to Bidders**

Consulate General of India, San Francisco (hereinafter referred to as CGI) will not be responsible to compensate for any expense or losses which may be incurred by the Bidder in the preparation and submission of his/her Limited Tender.

This is a Limited Tender based on the Schedule of Furniture and Specifications outlined in **Annexure I**. Bidders are required to review the entire Limited Tender Document. The firm must be capable of displaying its catalogue with detailed descriptions of the furniture to verify quality, including access through its listings on web portals for the evaluation.

The Limited Tender Price/amount and rates must be quoted in **USD** only.

The Bidders shall comply with all the conditions stated in the Limited Tender Documents. Decision on Limited Tender will be taken based on the final price quoted by the bidder.

At any time prior to the date of submission of the proposals, the CGI may issue an addendum.

The Limited Tender may be disqualified for any reason including, but not limited to the following:

- > If the Bidder sets forth any conditions which are unacceptable to the CGI.
- > If there is evidence of collusion between Bidders.

### Note:

Bidders must adhere to prescribed US laws and regulations concerning code of integrity, safety and health, labor regulations, etc. All rates against items of works shall be exclusive of all applicable Taxes.

The Bidder must read carefully all the Limited Tender Documents, Specifications, etc. The quoted Limited Tender price should be inclusive and complete in all respects.
